Ombudsman Office Longshore Legal Aid at 1-866-485-9393

This program was created to help address the quality of care and quality of life experienced by residents who reside in licensed long term care facilities such as nursing homes, homes for the aged, and adult foster care facilities. There is no fee. Services include investigating complaints, suggesting remedies, and assisting with resident rights, payments, issues, guardianship, and nursing home placement.

Medicaid Eligibility Your eligibility is determined by both your medical and financial need. Go to http://www.michigan.gov/documents/AttachA_NF_LOC_Criteria_Form-WEB-BLANK_107510_7.pdf for the **Michigan Medicaid Nursing Facility Level of Care Determination**. This official document is used to assess medical need. In general, Medicaid pays when your income is less than the cost of nursing home care and you meet medical eligibility. Annual State Survey Each nursing home facility must post this report and make it available to the public. Surveys reports (Form CMS 2567) describe in detail any regulations not met and gives examples of why they are not met.

NURSING HOME CARE: DIFFERENCE BETWEEN SKILLED AND BASIC CARE

If someone is unable to care for themselves due to physical, emotional, or mental conditions and when family caregivers cannot provide adequate care, a nursing home is appropriate.

Comparing Skilled (Subacute Care) and Basic Care
