

## **Discharge Instructions for Suspected Measles Cases**

Your illness may be caused by **measles**, a highly contagious (spreadable) disease that can be prevented by getting a vaccine. Please follow the instructions below to avoid giving this disease to other people in your home and community.

- Wear a surgical mask until you arrive at home. You may take off the mask inside your home.
- **Stay home** until your local health department contacts you with more instructions. If you don't hear from your local health department within 24 hours, call them using the contact information provided below.
- Considering quarantining (staying in a space away from other people)
  within your home. This can prevent the spread of your sickness to other household members who are not protected from measles.
- Do not go near pregnant people, people with weakened immune systems, or children under 1 years old.
- Make sure that all the people you live with are fully immunized (protected) from measles by getting vaccinated.
  - Check immunization records or talk with your doctor.
  - To be fully immunized, a person must get 2 doses of MMR vaccine given 28 days apart.
